





Once you have typed your message of help, send the message to 911 just like any other text

Important things to know about texting 911

► 1. It is a one way conversation and they cannot ask important questions until you send your text.



2. It is important you give the specific information on your first text. It will get help to you sooner.



▶3. 911 operators must be sure they send the right kind of help so give them correct information.



▶4. You must type in the address of where you need help. Cell phones don't give addresses like land lines do.



>5. If help is needed as a result of an assault, they will send police first with EMS standing by until the area is safe.



Example: EMS call



Need EMS at ENCSD, 1311 US HWY 301 S. Man having chest pains, fell on floor, passed out. He is in Vestal Cafeteria. I am deaf.



* Why tell 911 you are deaf? Because they will follow up with instructions or questions.*

Example: Police Call





Need police at 1311 US HWY 301 S. Wilson ENCSD. 2 boys fighting, no weapons, in front of Massey building. I have blonde hair, purple shirt, tan shorts; other boy has brown hair, red shirt blue pants. My name is Billy Smith. I am deaf.

Example: EMS Call





▶ Need EMS on McAdams playground at ENCSD, 1311 US HWY 301 S, Wilson. **Student Sam Sand** fell and cut his left leg and it is bleeding bad. I am John Smith. I am deaf.

Example: EMS Call






► I need a police officer. I am Jean Blue. Someone stole my compter out of my car. ENCSD, 1311 US HWY 301 S. Wilson. Car behind Vestal building Red Dodge van. I am with the car. I am deaf.

Example: Fire Department Call



Need fire department.
 Kitchen on fire. 123
 Adams St. Wilson.
 No one in house.
 Started at stove.



Things to remember §





I. When you text 911 be sure it is an emergency.



- 2. Give type of emergency:
- >-EMS
- -Fire
- >-Police





3. Location/ >address; building/ address)





• 4. Description of people involved and/or vehicle involved





▶5. Let them know you are deaf in first text so they know the call is not someone making prank calls.





▶6. Also lets 911 know that being able to obtain information by phone call is not an option.

Check with the county you live in to see if they have texting option.

Wilson County provides this service, but not all counties do.
